SECTION 4: First aid measures

4.1 Description of first aid measures

General information:	Take off contaminated clothing and wash it before reuse. In the event of cardiac arrest immediately perform cardiopulmonary resuscitation.
In case of inhalation:	Remove casualty to fresh air and keep warm and at rest. If breathing becomes irregular or ceases, apply rescue breathing or artificial respiration immediately, where required supply oxygen. If unconscious place in recovery position and seek medical advice.
Following skin contact:	After contact with skin, wash immediately with soap and plenty of water. In case of skin reactions, consult a physician.
After eye contact:	Immediately flush eyes with plenty of flowing water for 10 to 15 minutes holding eyelids apart. Remove contact lenses, if present and easy to do. Continue rinsing. Seek the attention of an ophthalmologist immediately.
After swallowing:	Rinse mouth. Do not induce vomiting. Danger of aspiration! Never give anything by mouth to an unconscious person. Seek medical aid in case of troubles.

4.2 Most important symptoms and effects, both acute and delayed

May cause allergic reactions in already sensitized persons.
Respiratory complaints, headache, dizziness, nausea.

Treat symptomatically.
